The [California Dental Association \(CDA\)](#) joins a growing list of researchers, dental and health organizations advising **against regularly mixing infant formula with fluoridated water to avoid discoloring babies' developing teeth (fluorosis)**. For a dental association to voice such a message is truly impressive! After all, the fact that fluoride is extremely toxic has been well known for close to a century, even though probably still 90+% of the dentists in the United States will still insist and demand that the teeth be painted with fluoride and that people drink fluoridated water. Hawaii has banned fluoride, the European Union joined the banning of fluoride, and now, a Dental Association actually admitting the truth about fluoride and its association to fluorosis! This is a major improvement, a major ethics change for the better!

In the meantime, we still have 68+% of the cities in the United States who are fluoridating the water. Remember this, cities can legally place 4 parts per million in the water. That's the Maximum Contamination Level, note, it's a contamination level! Not a supplement level or a health giving level.

Keep in mind that even with fluoride as low as 0.85% in the water, some 25% of the population will still develop dental fluorosis. So you see why it has always been such a political issue with the dental association.

Now, couple this idea with [fluoride as a powerful depressant sold as an antidepressant such as Prozac \(fluoxetine\)](#), which has to have a black label box which warns that some of **the side effects can include suicide and homicide**.
